#### **Note by the Secretary-General**

- 1. The Assembly of the International Seabed Authority is invited to note that Mehdi Remaoun (Algeria) resigned from the Finance Committee with effect from 30 April 2020.
- 2. Section 9, paragraph 5, of the annex to the Agreement relating to the Implementation of Part XI of the United Nations Convention on the Law of the Sea of 10 December 1982 provides that, in the event of the death, incapacity or resignation of a member of the Committee prior to the expiration of the term of office, the Assembly shall elect for the remainder of the term a member from the same geographical region or group of States.
- 3. By a note verbale dated 23 September 2020, the Permanent Mission of Algeria to the United Nations informed the secretariat of the Authority of the nomination of Abderahmane Zino Izourar to fill the seat on the Committee left vacant by Mr. Remaoun for the remainder of his term ending on 31 December 2021.
